



### **Autocross Is More Than Just An Adrenaline Rush**

Recent news about two possible racing venues coming to Oahu has a lot of adrenaline junkies excited, including yours truly. Over the years I competed in many NCCC sanctioned autocross events in the lower 48, and that rush of adrenaline is intoxicating as 460 horsepower roars to life, tires begin to squeal, and another Corvette achieves its ultimate purpose --- to go really fast!


When it comes to racing there are the higher risk High Speed and Drag Racing, which require professional racetracks, but if all you have available is a large parking lot then Low Speed Autocross is where the fun's at. This is where you take a large paved area and set up a course using orange cones to provide twists, turns and slaloms that keep the driver at or below approximately 50 mph (which makes it "low speed"). The course includes a digital start and ending gate that gives each racer their course completion time, and the times are also fed into a laptop where they are tallied against the other racers in your category. It is a safe and controlled environment where you can put both your car and your driving skills to the test.

It's more than just a 35 second rush as you navigate the course though. What I remember more fondly is the hours spent with friends setting up the cones, equipment, serving as a safety on the course, sharing a lunch between runs, and congratulating each racer on their improvements. It was a racing event, a social event, and a family outing for many of us who brought children and grandchildren to watch a Grandmother scream around the corner in her shiny ZR1. The 1963 Sting Ray featured a beloved one-year-only body feature that is still sought after by collectors today. The split rear window design of the 1963 Sting Ray was undoubtedly aesthetically pleasing. However, the design was canned before the following year's production run, as it was cited as a visibility issue. The 1963 Sting Ray also featured a 327 cubic-inch V8 that turned out an impressive 360 HP and was coupled with a 4-speed manual transmission.


